When making your application, keep the following in mind:

- 1. Our application round is called: **"Umeå School of Business, Economics and Statistics,** Fall 2024"
- 2. Select **Umeå School of Business, Economics and Statistics** as **Unit Responsible for the nomination round** even if you do not study at a program offered by us.
- 3. This application round is strictly for **fall 2024** and the **full academic year 24/25**.
- 4. Provide information on which subject/level you intend to study abroad under *Current Studies* in your Solemove application.

ELIGIBILITY REQUIREMENTS FOR VACANT SEATS

- Study full time at the time of your application (Some exceptions can be made regarding leave of absence).
- If you wish to apply through USBE exchange agreements but either:

Your non-completed studies exceed 22.5 credits, or

You have studied business/economics subjects to some extent but you don't fulfil the eligibility for the subject area (see <u>eligibility requirements</u>)

You may still apply, but it is up to the host university during their admission process to decide if you meet their eligibility requirements.
