See appendix. Written comments from the students were removed from the appendix, but general comments are summarized below.

Comments by course coordinator:

This was the second time that the course had a new coordinator.

In relation to last year, there were a few modifications to the course:

- A new syllabus was written, with clear expected learning outcomes.
- A new lab was introduced in which students performed particle reconstruction from cryoEM data.
- The Molecular Graphics sessions were greatly redesigned to include clearer instructions (this was a criticism from last year).
- One of the lab moments was removed and the final project was increased in length (from 1 week to 2 weeks).
- A Q&A session before the exam was introduced.

Comments to the overall course structure were positive. The course evaluation followed the LEQ format and there was a general increase in the scores of each section. The lowest scoring sections were the sense of community and the feedback received (see below for specific



comments). As last year, the students appreciated the different moments and the exposure to different teachers. The students were generally happy with the molecular graphics sessions.

Here are some suggestions for improvement:

- The overall pace of the course was considered low and the students feel like they can take on more material. There were two specific suggestions:
 - o Some extra voluntary reading.
 - o More lectures on topics like intrinsically disordered proteins or post-translational modifications.
- The exam could be done before Christmas not too leave a too large gap between the last lectures and the exam.

Some of these aspects will be implemented in the next iteration of the course.

The general suggestion for future students is to review each lecture every day and not leave everything to just before the exam.


Average response to statements about the learning environment

The first 22 statements examine the student's experience of the learning environment based on a number of factors that in empirical research have been found to promote learning in higher education.

At a more general level, the student's experience of meaningfulness (statements 1-7), comprehensibility (8-16) and manageability (17-22) in the learning environment are also examined.

The polar diagram below shows the mean value of the response to each statement using a numeric scale from 1 to 5 where 1 = "Strongly disagree" and 5 = "Strongly agree".












































