RESEARCH FOR THE FUTURE

At USBE research of a high academic standard is conducted in three main fields of study: business administration, economics and statistics. Our researchers collaborate with their colleagues at USBE, with researchers at Umeå University and at other Swedish and international universities.

Our seminar series are a focal point of continuous knowledge exchange with researchers from other universities who visit and present their results for us. One of the challenges that have to be faced by universities and university colleges is financing of research. Our research is financed by means of grants from the public sector as well as by grants from external funding sources. The external funding sources include research councils and foundations as well as collaborators from the business community and the public sector. During the year, despite tough competition, our researchers have been successful in obtaining funding for their research projects. Collaboration with external partners has contributed to the financing of PhD students studying at the Industrial Doctoral School for Research and Innovation at Umeå University. One half of our research funding has been obtained in competition with others. For a long time now USBE has had valuable collaboration with the USBE Endowment and the Per and Eivor Wikström Foundation. This kind of collaboration strengthens our research environment and provides good possibilities for interaction and international exchange of our researchers and students.

The Erik Kempe Award



The Erik Kempe Award is a biennial award for best article published in the area of environmental and resource economics. Thanks to generous funds from The Kempe

Foundation, the Erik Kempe Award was introduced in 1995, and it is based on cooperation between Umeå University and the European Association of Environmental and Resource Economists (EAERE). The Department of Economics is the host institution for the Erik Kempe Award, and Professor Thomas Aronsson is chairman of the prize committee.

The 2017, the Erik Kempe Award went to Mads Greaker, Statistics Norway, and Kristoffer Midttømme, Menon Economics, Norway, for their article "Optimal Environmental Policy with Network Effects: Will Pigouvian Taxation Lead to Excess Inertia?" published in *Journal of Public Economics* 143, 27-38, 2016.

USBE RESEARCH INSTITUTE

The USBE Research Institute was founded in order to promote research at USBE. The institute may award funding to individual researchers and research groups in internal competition on two occasions each year. In particular, funding is provided to strengthen new/emerging research areas ('seed money') in order to support activities related to existing research programs, and to strengthen research collaboration with the surrounding community.

RESEARCH ENVIRONMENTS AND CENTERS AT USBE

AUDIT QUALITY

A central research issue is to understand the underlying factors determining the audit quality and demand for audit services. The key topics of the research include, inter alia, influential factors affecting, for example, the characteristics of an auditor signing an audit report, as well as the structure and roles of an audit team. Other topics have to do with the ways in which investors and creditors react towards different audit quality levels and different types of external attestation, auditors' salaries, factors affecting audit fees, and whether information contained in audit reports and management reports can be used in order to predict bankruptcies.

FINANCIAL DECISIONS AND RISK-TAKING BY INDIVIDUALS

The research focuses on individual financial decisions and risk-taking as well as on factors governing individual decisions relating to financial risk. The main topics include, for example, understanding of pension savings outcomes, individual participation in financial markets, as well as the role of financial accounting information in individual decision-taking.

PIN - PROJECTS, INNOVATION AND NETWORKS

Research in the field of PIN focuses on the profound challenges faced by society when trying to expand the organizational and business sector boundaries in order to make effective preparations for uncertainty and change in order to promote innovation and boost competitiveness. PIN consists of five partially overlapping research programs: Business incubation and business development, Extreme Environments - Everyday Decision (TripleED), Open innovation, Competition and Temporary Organization.

RISEB - RESEARCH INSTITUTE FOR SUSTAINABILITY AND ETHICS IN BUSINESS

Research in business sustainability focuses on ethical, social and environmental issues and how these affect the surrounding community in order to improve our understanding of problems and issues encountered by individuals and organizations over time. Sustainability in business consists of several research projects involving both senior researchers and doctoral students. These projects can be encountered in all the business administration sub-disciplines, and have to do with, for example, sustainable business models, social innovation, sustainable consumption and investments.

TEPN - THE ECONOMIC POLICY NETWORK

Economic policy has been a common theme for much of the research in Economics at Umeå University during the last two decades. It also represents a research area which the university prioritizes and which has received additional grants from Umeå University by means of a five-year start-up professor package. Researchers belonging to the network study economic policy approaching a wide range of issues relating to different areas, such as public economics, behavioral economics, markets where public and private actors meet, labour market economics and empirical methods.

CERE - CENTRE FOR ENVIRONMENTAL AND RESOURCE ECONOMICS

CERE is an interdisciplinary research center involving collaboration between Umeå University and the Swedish University of Agricultural Sciences in the field of environmental and natural resources economics. The center is located at USBE at the

Department of Economics. CERE's research team belongs to one of the most prominent in Europe as regards issues concerning natural resources, green accounting, valuation methods of non-market goods and services, conflict resolution and design of policy documents in the areas of environment, climate and energy. They hold seminars and workshops in the subject area, link together various research groups and act as a platform for creative and robust research in the area.

STATISTICS TO SERVE SOCIETY

Research at the Department of Statistics focuses on developing statistical methods and software for the analysis of large and complex collections of data. This research is of great importance to society, and the researchers collaborate with various government authorities which perform evaluation studies based on registry data. Among interesting research projects can be mentioned those evaluating labour market employment policy programs, quality of medical care, large-scale proficiency tests and international knowledge assessments.

Stat4Reg - STATISTICAL RESEARCH LABORATORY FOR THE ANALYSIS OF REGISTRY DATA

Stat4Reg is a research laboratory at the Department of Statistics, being run in collaboration with partners from other university units, for example, CEDAR (Centre for Demographic and Aging Research) and Umea's SIMSAM Laboratory which offers the world's most unique research infrastructure for registries. Registry-based research is a high priority research area at Umea University, and Stat4Reg is financed by university grants by means of a five-year start-up professor package as well as external funding from the largest Swedish research financiers.

OTHER RESEARCH ENVIRONMENTS

In addition to our own research environments our researchers are also active in other research environments, such as CERUM (Center for Regional Science), CEDAR (Center for Demographic and Aging Research), CiiiR (Centre for Inter-organizational Innovation Research), USGS (Umeå Center for Gender Research), RSAI (The Regional Science Association Sweden) and UFBI (Umeå Center for Functional Brain Imaging).


The next step in my career is to move back to Stockholm and tackle new challenges at the Riksbanken.

We provide an excellent academic environment where teaching is closely linked to theory and practice. The knowledge and skills gained in the course of study give the students a solid foundation in business administration, economics and statistics and allow them to choose a specialization in various fields.

The Umeå School of Business, Economics and Statistics is centrally located at the Umeå University Campus. We offer a wide range of programs and courses. During 2017 we have launched new specializations in Environmental and Resource Economics and

Health Economics at the Master´s Program in Economics and we are now looking forward to the start of our new master's program in statistics. In 2017 there were 12 programs and 159 courses to select from and also great opportunities to follow part of the study program abroad. Each year we also accept a large number of exchange students from different parts of the world. Together with our researchers the international students contribute to making our study and work environment more dynamic and diverse.

With the help of competent teachers and researchers our students develop knowledge and skills, gain understanding of leadership in business and administration, as well as develop awareness of social and environmental responsibility in a global perspective.

SUSTAINABILITY WITHIN OUR EDUCATION

Universities shall promote sustainable development in their operation, which implies that the current and future generations are secured with a healthy and good environment, economic and social wellbeing and justice. (§5, The Swedish Higher Education Act.)

We are proud to be a business school that integrates sustainable development in our education, our research, and our collaborations, and we have been certified by ISO 14001 since 2015. The Swedish Higher Education Authority has evaluated the work of all Swedish universities to integrate sustainable development in education in 2017, and USBE's work is highlighted in the report about Umeå University.

Together with the external ISO 14001 review in 2017 that did not result in any additional measures needing to be taken, this shows how successful our work with sustainable development has been. We can also see clear progress based on the theses written by our students. Regardless of the subject of the thesis, the students all show good abilities to reflect upon sustainability and ethics.

This shows that we offer a learning environment of high quality that stimulates independent and critical thinking with a proactive approach to questions concerning sustainable development. This allows for conceptual and empirical research on sustainable development and the effects of sustainable values and shows that collaboration with businesses and society increases the knowledge of sustainable development.

We want to stand out when it comes to the existing big challenges of globalization and the environment. Our work in these areas is coordinated by USBE's sustainability coordinator and sustainability committee.

TOGETHER WE SHALL CONTINUE TO DEVELOP

In 2017, together with the USBE board, the International Advisory Board, and the Business Advisory Board, we have had interesting dialogues about digitalization and sustainable development. HONORARY DOCTOR

STEWART CLEGG

Honorary Doctor of Philosophy at the Faculty of Social Science

Stewart Clegg was awarded the title of Honorary Doctor of Philosophy at the Umeå University Annual Celebration

Ceremony in Aula Nordica.

Stewart Clegg is an internationally established researcher with both Australian and British citizenship and is a professor of organizational science at the University of Technology Sydney in Australia. His scientific production is characterized by the ambition to place management and organization studies in a global context based on a critical and reflective stance. His research efforts have led him to many successful collaborations and co-authorships.

As the chair of professorships in both sociology and organizational science, he has been guided by a sociological vision that has enriched the analyses of both private and public organizing in areas such as strategy, politics, ethics, sustainable development, design, and urban development. Stewart Clegg has visited Umeå University on several occasions, and he has participated in research seminars and teaching as well as acting as a faculty opponent. He also had an active role as a member of the scientific reference group in the research project "Strategy, Design and Organizing in City Development Processes", which to a large extent focused on the City of Umeå's European Capital of Culture initiative before, during, and after the implementation.

JIM ANDERSÉN,

Professor in Business Administration with specialization in Entrepreneurship

Jim Andersén's research focus is on entrepreneurship and strategy development in primarily small and mediumsized companies. How companies can create and, above all, maintain high



profitability over time has always been a red thread in Andersen's research. He has, among other things, studied how ownership and management of different resources affect the long-term profitability of companies, as well as the impact that entrepreneurial action and interorganizational learning have on a company's competitiveness.

Jim Andersén was born in 1976 in Hallstahammar in Västmanland. In 2005 he completed his PhD work in the field of industrial economics and organization at Mälardalen University. He has worked as an assistant professor at Örebro University and as an associate professor at the University of Skövde. During the period 2012-2017, he served as the research director for the Strategic Entrepreneurship research group.

GIOVANNI FORCHINI,

Professor in Econometrics.

As the importance of econometrics and statistics increases in academic research, business, and society in general, it is important not only to develop new methodologies to tackle new problems, but also to fully understand the



properties and behaviors of such methodologies in different situations.

As an econometrician, Giovanni uses mathematics as a tool to investigate the properties of econometrics and statistical procedures. He is especially interested in understanding the small-sam-

ple properties of tests and estimators, in developing valid inferential procedures for estimating aspects of statistical models that may or may not be identified, and in investigating the effects of dependence among the observations in a sample due to common shocks.

Giovanni Forchini was born in Bergamo, Italy, in 1967. He received his PhD at the University of Southampton in 1998. From 2010 and 2015 he was a professor at the University of Surrey. He worked at the University of Warwick as a visiting professor in 2016, and he came to Umeå in 2017.

MANY OPPORTUNITIES

All programs at USBE have at least one semester open for studies abroad, and some of the programs have as many as three semesters designed for studies abroad. We have about 70 partner universities, chiefly in Europe, but also in Brazil, India, China, Mexico, South Africa, Russia, and China - all of them selected especially for our students. Students who would like to study farther away can avail themselves of Umeå University's global agreement offering an opportunity to study in North America, Oceania, and Asia.

OUR STUDENTS

USBE is a top school at Umeå University with regards to student mobility. Of all the students who go on to study abroad under the Erasmus exchange program, 50% come from USBE.

Almost half of our students following the Professional Degree Programs study abroad in their third year, and one-fourth of our Professional Degree Programs and Master's Programs students do the same at the advanced level.
