


## WE INTEGRATE COMPETENCIES INTO EDUCATION

We strive to ensure that our courses and programs are relevant and useful, preparing students for both future careers and for contributing to society.

In 2022, we decided to focus our courses and programs specifically on the six competencies illustrated in the figure. Analytical, critical and independent thinking are seen as umbrella competencies that have an impact on the other competencies. According to USBE's mission statement: "We fulfill our mission by offering a high-quality learning environment that encourages analytical, critical, and independent thinking". USBE's Strategy 2019-2025 also states that students must be prepared to act in relation to a dynamic and changing world, an ability that is developed through analytical and critical thinking.

"Responsible approach," as a core competence related to USBE's mission and strategy, is found in the middle. Furthermore, the ability to adopt a responsible approach should be reflected in the way that students communicate, solve



Digital competence and data literacy are related to the strategic ambitions of preparing our students to deal with societal challenges and opportunities such as digitization, artificial intelligence and automation. The responsible approach also applies to self-leadership and relates to the USBE's aim to develop courses so that students are encouraged to take responsibility for their own learning and take an active role in the learning process. The content and design of the courses must enable students to reflect and to use and develop critical thinking skills.



#### PROGRAM DEVELOPMENT

In 2022, USBE developed a new first-cycle business and economics program with an international focus, taught in English. The choice of specialization is in line with USBE's mission and vision, and the combination of courses will prepare students to operate in a globalized world where workplaces are characterized by change and complexity.

Several of the new courses included in the program are based on USBE research, such as the courses in business analytics and data visualization, economic modelling, project management and innovation, technology, and entrepreneurship.

This development has been led by a project group with representatives from all USBE departments, and the content and structure have been discussed and anchored in various forums. The program will be launched in the fall of 2023. Senior Lecturer Irina Alexeyeva has been involved in developing the program.

#### WHAT MAKES THE PROGRAM NEW AND RELEVANT TO STUDENTS AND EMPLOYERS?

- The global market is evolving rapidly, and technological developments are changing the world of business. These changes are important to understand and manage, and the new international business program prepares students for this.

#### HOW DOES IT DIFFER FROM OTHER USBE PROGRAMS?

- This program places greater emphasis on business analytics: understanding, evaluating, processing and analyzing data in order to responsibly transform it into information and knowledge for evidence-based decision-making. It will prepare students for work that places increasing demands on data management.

#### COLLABORATIVE EDUCATION

Through, for example, guest lectures, degree projects and internships, we enable actors in the business world and the public sector to engage in a mutual exchange with students, benefiting all parties. This creates opportunities for students to familiarize themselves with and prepare for the job market.

#### SURVEY

In a survey of 2021, business and economics graduates, 92% reported a good to perfect match between education and work. In the same survey, a recurring piece of advice from alumni was to do an internship, and several reflected on the role of internships in their first job after graduation.

- Internships are crucial! That was a big reason why I got the job, and it was also good that I had a broad education.

"I feel that my internship really motivated me for my future studies. It has given me a clearer vision of where I want to go with my studies and what I want to learn. I also feel that my self-confidence improved."

#### HHUS 25 YEARS OLD

USBE's student association, HHUS, turned 25 in 2022. This was celebrated during a week in November. The importance of the student association to student life is greatly appreciated through all the activities organized and networking opportunities. ### STUDENT RECRUITMENT

USBE's strategic aims for education include strengthening national and international student recruitment. During the year, the following activities were carried out, among other initiatives.

#### **CAMPAIGNS IN SPRING 2022**

For recruitment to our Professional Degree Programs and the Statistics and Data Science Program, Social media campaigns were run in the spring.

Similar campaigns were carried out for prospective Master's students.



#### FALL CAMPAIGNS FOR THE 2023 ACADEMIC YEAR

This fall's social media campaigns focused on our new three-year International Business and Economics Program, starting in the fall of 2023. As the program is in English, the first part of the campaign was targeted at Germany and Finland.

The second part of the campaign started just before Christmas in Sweden, and will run throughout spring of 2023, until application closes in April.

#### **OPEN HOUSE AT UMEÅ UNIVERSITY**

Each year, Umeå University holds an information day for high school students, and in 2022 it was held for the first time during the fall semester. As many as 3,000 students from all over northern Sweden visited campus to see and experience student life in Umeå.

USBE participated with six well-attended information sessions, where we informed the students about our programs and courses and life at the business school.

#### SACO STUDENT FAIR IN STOCKHOLM

The fair attracts more than 20,000 visitors annually, and, for the first time since the COVID-19 pandemic, it took place in person. USBE, as well as Umeå University, were present with stands manned by study counsellors and students.

In conjunction with the fair, a social media campaign was conducted locally in the Stockholm area.

### INTERNATIONAL LEARNINGENVIRONMENT

USBE is known for its international learning environment, with a high proportion of international students and a large number of outgoing students. Internationalization is an important issue and a continuous work in progress.

Internationalization includes opportunities for students to study at one of our partner universities and for teachers to be mobile. Our students will be given international perspectives on the subjects they study and are offered an international study environment.

We are continuously reviewing our agreement portfolio to offer more countries for mobility. During the year, we signed two new agreements. One with the Luxembourg School of Business, in Luxembourg, and another with Pusan National University, in South Korea. We now offer students around 70 partner universities to choose from, and our students can also choose from Umeå University's agreements.

#### **POPULAR DESTINATIONS IN 2022**

In 2022, France was a popular destination for studies abroad, and it is also a country from which we have received many incoming students.

Our incoming and outgoing students can apply for additional funding through our partnership with the Per and Eivor Wikström Foundation, which contributes to scholarships for student and teacher mobility with links to Francophone countries.

The UK and Portugal have also been popular countries for students to apply for exchanges in 2022. Regardless of where they study abroad, most find it to be the best period of their lives and report feelings of achievement.

#### MOBILITY

During the year, 176 USBE students chose to apply to study abroad, and 125 departed for various countries. In the opposite direction, we welcomed 149 incoming exchange students in 2022 from our partner universities.

#### STUDY VISITS/EXPERIENCE EXCHANGE

Directors of Studies in Business Administration Malin Näsholm and Dan Frost visited Excelia Business School in La Rochelle, France, considered a leader in sustainable development and corporate social responsibility (CSR).

Lessons learned from the visit include insights regarding how business education can include increased social and local engagement (societal impact) and how USBE can develop pedagogical support and work with digitalization in teaching. There was also an opportunity to exchange experiences with sustainability, systematic quality management and AACSB accreditation.

The study visit was funded by a grant from the Per & Eivor Wikström Foundation.

#### PER AND EIVOR WIKSTRÖM FOUNDATION SCHOLARSHIP

Associate Professor Tatbeeq Raza Ullah, Business Administration, was awarded a scholarship from the Per and Eivor Wikström Foundation for a project in collaboration with researchers at the Grenoble Ecole de Management, France.



#### STUDENT STUDY-ABROAD EXPERIENCES

Students who travelled from France to Umeå for their exchange semester have expressed satisfaction with their stay here, and state that the scholarships contributed to opportunities to explore northern Sweden and its beautiful nature. Similarly, our students on exchange in France describe the scholarship as helping them to get to know the country, the culture and the French language.

Several other interesting observations from students are the differences in the study systems at many universities abroad compared to Sweden. Here, you take one course at a time and finish it before starting a new course, instead of taking several courses at the same time and being examined in all of them at the end of the semester. The students found it a good experience to try both methods, as they require different study techniques. The incoming students also emphasize appreciation for the peace and quiet in Umeå, the possibility to cycle everywhere and the more informal relations between students and teachers.

#### **USBE PEDAGOGICAL PRIZE**

The Pedagogical Prize for 2022 was awarded to Associate Professor of Statistics Lina Schelin.

The theme for nominations was: Pedagogical innovation for student engagement in physical and/or digital education environment. Lina was distinguished for engaging with and including students in her teaching, and for creating an atmosphere in the classroom (whether in-person or digital) that makes students feel safe and where learning is at focus.

#### NORDEA'S THESIS AWARD. **DIVERSITY AND INCLUSION**

Nordea's thesis award aims to stimulate and maintain students' interest in how issues in business administration, economics and statistics can be related to diversity and inclusion. This is the first year

that the award has been given, and funding was been made possible by USBE's partnership with Nordea | BBU Botnia.

The award was given to Hedda Dahlström and Frederik Lund-Petersen, USBE. The thesis entitled "Kvinna och ledare i techbranschen: En kvalitativ studie om kvinnors upplevelser av anpassning till maskulina könsnormer i den svenska techbranschen" was awarded SEK 15,000.

The paper deals with a relevant empirical problem regarding the lack of female leaders in the tech industry, and the authors approach this topic with an independently chosen and theoretically interesting angle in the form of female managers' own experiences of adapting their leadership to masculine gender norms.

#### THESIS PRIZE IN SUSTAINABILITY AND BUSINESS ETHICS

The Research Institute for Sustainability and Ethics in Business (RiseB) has established an annual national scholarship to encourage business students to take an interest in and study sustainability and business ethics.

In 2022, two theses were awarded the prize. The winners were Martina Reppen, Södertörn University, and Henry Müller and Felix Pahl, Stockholm School of Economics. Both theses received a scholarship of SEK 25,000 funded by Umeå Energi.

The decision to award two thesis prizes is unique, and a consequence of the very high quality of both theses. Together, they identify opportunities for and challenges to accelerating sustainable transformation in both the private and public sectors.

#### **USBE ALUMNI SCHOLARSHIP** FOUNDATION AND SWEDBANK PRIZE

The 2022 recipient of the USBE Alumni Foundation and Swedbank scholarship was Hjalmar Johnson, a student in the **Business Administration and Economics** Program. The scholarship of SEK 10,000 was financed by Swedbank.

The prize went to Patric Beijer and Moa Pålsson, USBE. The thesis entitled "Corporate Sustainability Performance and the Risk of Financial Distress" was awarded SEK 20,000.

In its decision, the jury mentioned that the essay is characterized by a well-motivated and topical issue, which has been analyzed in a meritorious manner using relevant methodology. The study contributes both theoretical and practical knowledge on the relationship between corporate sustainability and the risk of financial distress.

## RESEARCH

Our employees are our most important resource, and our stakeholders include students, our partners and funders. We are also characterized by good student-employee relations, the involvement of students and other stakeholders in our regular activities, and a well-developed system to ensure student learning processes.

It is essential that an academic institution such as ours provide the conditions for high-quality and socially relevant education, research and collaboration. This is achieved by being scientifically based, independent, dynamic and having an international perspective in addition to a regional and national base. Research at USBE ranges from basic research to policy-oriented research, and from theoretical to empirical, and includes the application of quantitative and qualitative methods. We also develop new methods. Our employees are internationally respected and participate at various levels in public debate as experts and as members of councils, boards and committees. Our scientific publications are of high international quality.

### AWARDED RESEARCH GRANTS

While our research receives direct government funding, it is also largely funded by external grants and contracts. External research funding comes from research councils, foundations, and external partners in industry and the public sector, and is the result of successful research applications made by our research fellows.

The following is a brief presentation of projects awarded research grants where USBE research fellows are the main applicants.

## EFFICIENT GRID USE AND DEMAND FLEXIBILITY IN LOCAL DISTRIBUTION MARKETS

In this project, the researchers, together with Umeå Energi Elnät AB, are investigating how demand response can reduce congestion in electricity networks and improve efficient grid utilization. They will study, for example, the role of electric cars, and how local grids can meet the challenges and take advantage of the opportunities presented by battery charging.

## SIGNALING IN A WORLD OF INFORMATION OVERLOAD AND CHEAP FAKES

Functioning markets require that those who have the resources (investors or customers) know the quality of those who seek the resources (companies, entrepreneurs), where this quality is often difficult to observe. To address this, high quality companies or entrepreneurs can send signals indicating their quality by doing something that someone with low quality cannot do, such as giving a long warranty period or hiring a well-merited CEO. This mechanism is described by signaling theory, which is a fundamental theory in information economics.

Today, we live in a world where customers or investors are inundated with information and where virtually anything communicated via digital media can be easily falsified, making it difficult for customers or investors to detect and assess signals sent by companies or entrepreneurs. In this project, researchers are updating signaling theory by studying how signaling works in a world of information overload and cheap fakes, to better under-

stand how high quality producers can still signal their quality and keep the market efficient.

#### **ORGANIZING THE ULVÖ CONFERENCE 2024 & 2025**

Each year, the CERE research center organizes an international conference in June on the island of Ulvö. CERE is an interdisciplinary research center in the field of environmental and natural resource economics, located at USBE and shared between Umeå University and the Swedish University of Agricultural Sciences.

#### DYNAMIC RELATIONSHIPS BETWEEN CARDIOVASCULAR, SOCIAL AND BEHAVIORAL RISK FACTORS AND COGNITIVE AGING

The aim of the project is to explore the relationship between modifiable lifestyle factors and cognitive aging and the possible effects of lifestyle interventions at the population level. With longitudinal data from more than 110,000 respondents from the Survey of Health, Ageing and Retirement in Europe (SHARE), the researchers are in a unique position to improve understanding of the etiological role of these lifestyle factors. To better answer these questions, an important part of the project will also be to develop new machine-learning methods for complex longitudinal data with time-related variables.

#### INNOVATIVE STATISTICAL AND MACHINE LEARNING METHODS FOR COMPARING PERFORMANCE AND OUTCOME IN REGISTER DATA STUDIES

The aim of the project is to develop, evaluate and implement innovative statistical methods, including modern machine learning methods, to draw inferences based on register data, including education and health registers. The study has three themes:

- Develop innovative statistical methods that combine information from different measurement methods (questions, scales and instruments) and improve the normalization of results from these.
- Develop and adapt modern machine learning methods to investigate inequalities in outcomes and performance using register data.
- Implement the new methods with register data and develop software for researchers and practitioners.

#### BANKRUPTCY AND CRIMINALITY

The study examines two issues related to bankruptcy and criminality. The statutory audit of small companies was abolished in 2010 and it has been suggested that this resulted in increased criminality. The first issue studied is whether there is a causal association between abolished statutory audits and criminality.

The second issue examined in the research is how common it is that entrepreneurs abuse bankruptcy by leaving debt unpaid and start a new business in the same industry after a bankruptcy. The study examines the phenomena from several perspectives, for example, whether those entrepreneurs are associated with more criminality and whether the bankruptcy is associated with a smaller jump in income than for other entrepreneurs going bankrupt.

## UNDERSTANDING AND MANAGING COOPETITION FOR SUSTAINABILITY: PROCESS AND OUTCOMES

The project plan is based on the findings of the doctoral thesis that investigated "coopetition for sustainability" as a phenomenon where actors cooperate and compete simultaneously with the intention of achieving sustainability goals.

The project is supposed to examine the following aspects: (1) the challenges of information complexity in coopetition for sustainability and how to deal with them; (2) power and leadership in sustainability projects organized in cooperation between competitors; (3) the role of cultural differences in coopetition for sustainability. It is important because despite many studies on cultural differences, information management, organization,

extent research knows little about how these aspects affect coopetition for sustainability.

#### ECONOMIC IMPLICATIONS OF THE GREEN TRANSITION

The main objectives of the project are (a) to examine the effects of new green industrial investments and geographical mobility on local labor and housing markets, and (b) to analyze the adoption of residential photovoltaic (PV) systems. Main objectives in part (a):

- Examine the effects that new industrial investments have on local labor market outcomes, migration patterns, and the regional distribution of human capital.
- Analyze the role of geography and housing in the search process for new jobs and employees.
- Analyze how the state of the housing market interacts with the local labor markets.

Key questions in part (b):

- To what extent are owners of PV both producers and consumers of electricity?
- How do house owners with PV differ from those who have not invested in PV?

- Workshop on Oral Presentations a workshop on verbal and non-verbal communication was organized in the fall

#### VISIT FROM RIKSBANK GOVERNOR STEFAN INGVES

In December, we were privileged to welcome Stefan Ingves, governor of the Riksbank, who spoke to a packed house in Aula Nordica. Mr. Ingves spoke



about Swedish monetary policy in an international context. Based on the economic development from early 1990s, he described the current situation. For obvious reasons, the lecture and related questions focused on Riksbank's independence vis-à-vis Parliament and its task of maintaining a fixed monetary value.

It was an honor to welcome Stefan Ingves back in the same setting where he made his first speech, in February 2006, shortly after becoming governor of Riksbank.

#### **RESEARCH CONFERENCE IN JAPAN**

In November, a delegation from Umeå University participated in a bilateral research conference organized at Kyushu University, Japan, together with 19 other Swedish and Japanese universities. The theme of the conference was "Sharing ONE Future: Integrative Knowledge and Sustainable Transformation Towards a Better World". The participant from USBE was Professor Tomas Blomquist.

#### NETWORKING MEETING WITH THE NEWLY ESTABLISHED SILF REGION NORTH GROUP

SILF *Region North* and USBE jointly held a networking meeting at Umeå University to launch SILF *Region North*. We started with a seminar, where Anna Bergvall of Wibax discussed their journey, their commitment to electric-powered tank transport and their approach to sustainability.

#### SNS ECONOMIC POLICY COUNCIL REPORT 2022: PUBLIC PROCUREMENT

In January, the SNS Economic Policy Council published its 2022 report: *SNS Economic Policy Council Report 2022: Public Procurement*, by research fellows Professor Sofia Lundberg, USBE, Malin Arve, Associate Professor in Economics, Norwegian School of Economics, Mats A. Bergman, Professor of Economics, Södertörn University, and Lars Henriksson, Professor of Law, Stockholm School of Economics.

A major problem with regard to public procurement is that buyers are not allowed to take previous experiences with suppliers into account when evaluating tenders. In order to remedy this, the SNS Economic Policy Council proposes introducing rating systems for suppliers to the public sector similar to systems used online to rate taxi and hotel services. Upon publication, the research fellows also wrote an opinion piece in Dagens Nyheter.

#### AI MANAGEMENT: A FOCUS AREA OF THE CENTRE FOR TRANSDISCIPLINARY AI

Professor Markus Hällgren, Business Administration, together with Professor Jonny Holmström, Informatics, was appointed coordinator of the "AI management" focus area at the newly established Centre for Transdisciplinary AI (TAIGA), at Umeå University. AI management is one of eight focus areas. The aim of each focus area is to promote related issues in research, teaching and collaboration. The focus area coordinators are part of the Centre's management team. Each focus area is chosen over a four-year period.

The purpose of TAIGA is to promote AI research and collaboration within Umeå University, including research into AI's applications and consequences, and to create a strong international research profile for the University in this area.

#### **RESEARCHERS IN THE MEDIA**


