When making your application, keep the following in mind:

- 1. Our application round is called: **Umeå School of Business**, **Economics and Statistics**, **Autumn 2025**
- 2. Select **Umeå School of Business, Economics and Statistics** as *Unit responsible for the nomination round* even if you do not study at a program offered by us.
- 3. This application is strictly for **autumn 2025** and the **full academic year 25/26**.
- 4. Provide information on which subject you intend to study abroad under *Current Studies EU subject area at home* in you Solemove application.

ELIGIBILITY REQUIREMENTS FOR VACANT SEATS

- You are registered and actively studying a course or programme at Umeå University.
- If you wish to apply through USBE exchange agreements but either:

Your non-completed studies exceed 22,5 credits, or

You have studied USBE subjects to some extent but you don't fulfil the eligibility for the subject area (see <u>subject requirement</u> under eligibility requirement),

You may still apply, but it is up to the host university during their admission process to decide if you meet their eligibility requirements.
